

## INVITATION TO BID

### PROCUREMENT OF VARIOUS HOSPITAL SUPPLIES UNDER ORDERING AGREEMENT LIST (OAL)

IB No. 3 s, 2019

1. The *Region 1 Medical Center*, through the *General Appropriations Act / Trust Income of 2019* intends to apply the sum of *Thirty One Million Fifty One Thousand Eight Hundred Ten Pesos (P 31,051,810.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Procurement of Various Hospital Supplies under OAL: Drugs and Medicines with Bid Reference No. 28-2019*. Bids received in excess of the ABC for each item/lot shall be automatically rejected at bid opening.
2. The *Region 1 Medical Center* now invites bids for *Supply and Delivery of Drugs and Medicines for CY 2019*. Delivery of the Goods shall be completed within one hundred eighty (180) calendar days. Bidders should have completed, within the last two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *Region 1 Medical Center, Bids and Awards Committee (BAC) Secretariat Office* and inspect the Bidding Documents at the address given below during 8:00AM to 5:00PM, Monday to Friday except Holidays.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *May 8, 2019 to May 22, 2019* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Thousand Pesos (P 5,000.00)*. Bidders must bring *DTI & valid ID as proof of ownership for bidders (Sole Proprietorship) and Original Copy of Secretary's Certificate (Corporation) or Original Copy of Special Power of Attorney (SPA) for representative (Sole Proprietorship)*.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The *Region 1 Medical Center BAC* will hold a Pre-Bid Conference<sup>1</sup> on *May 15, 2019, 10:00AM* at the *MANCOM Conference Room, 2<sup>nd</sup> Floor, Administrative Bldg., RIMC, Arellano St., Dagupan City* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *May 28, 2019, 9:00AM*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on *May 28, 2019, 10:00AM* at the *MANCOM Conference Room, 2<sup>nd</sup> Floor, Administrative Bldg., RIMC, Arellano St., Dagupan City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *RIMC-BAC* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
