RESOLUTION OF THE BIDS AND AWARDS COMMITTEE (BAC), REGION 1 MEDICAL CENTER RECOMMENDING APPROVAL ON THE PROPOSED LIST OF ITEMS TO BE INCLUDED IN THE BIDDING FOR THE PROCUREMENT OF INFORMATION TECHNOLOGY FOR CY 2020, IN ACCORDANCE WITH THE REVISED IRR OF RA 9184.

WHEREAS, the approved Annual Procurement Plan for CY 2020, herein attached and made an integral part hereof, indicated items to be procured under general categories namely: goods, services, and infrastructures pursuant to the Revised IRR of RA 9184;

WHEREAS, the consolidated list of items were prepared with reference to the Project Procurement Management Plan (PPMP) submitted by the different end-user units in accordance with the CY 2020 Budget approved by the Medical Center Chief;

WHEREAS, the attached Annex "A" indicates the list of items placed under Ordering Agreement List (OAL) for the Procurement of Information Technology for CY 2020, with Bid Ref. No. 08-2020;

WHEREAS, the "Lot Bidding Scheme" is more advantageous and in the best interest of the Government in terms of contracts awarded since procurements through lot bidding scheme have higher success rate than procurement conducted under "Line/Partial Scheme";

WHEREAS, the grouping of items into different lots were reviewed by the BAC based on record available (e.g. procurement history, supply inventories, market research), to ensure competition amongst prospective bidders;

WHEREAS, the lot bidding scheme fixed the milestone for the completion of the bidding process, and the failure of bidding is minimized, thus ensuring availability of stock in the inventory that will cater patients especially those classified under the No-Balance Billing (NBB) category;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED that the Bids and Awards Committee (BAC) recommends to the Medical Center Chief, the approval of items placed under Ordering Agreement List (OAL) for the Procurement of Information Technology for CY 2020, with Bid Ref. No. 08-2020.
